TRANSPORTATION WEEKLY UPDATE – House Trust Fund Bailout Is \$5 Billion July 28, 2009

Immediately after today's *Transportation Weekly* went out, the chairmen of the House Ways and Means Committee and the House Appropriations Committee introduced the attached legislation, H.R. 3357, which will likely be considered on the House floor under suspension of the rules tomorrow.

Among other things, the bill transfers \$5 billion from the general fund of the Treasury to the Highway Trust Fund's Highway Account.
