Automated Vehicle Policy: from Speculation to Legislation

With input from Eno's Digital Cities Advisory Board, Eno crafted two papers on automated vehicle policy: **Beyond Speculation**, a multifaceted set of recommendations that address the most pressing federal policy issues for AVs, and **Adopting and Adapting**, recommendations to states on how to prepare for an automated future. **Beyond Speculation directly informed pending legislation** on the federal level and Eno continues to present its recommendations and meet with stakeholders across the country to **advance smart AV policies at the state and local level** that encourage innovation while still protecting the public interest.



An Objective Voice on Aviation Policy: Educating Policymakers + the Public

Eno's Aviation Working Group brought together stakeholders to understand how best to **modernize the nation's air traffic control (ATC) system**, concluding that only governance and funding reform of the existing federal structures could accelerate the implementation timeline. Congress has **used the recommendations to help draft pending legislation**. In addition, Eno launched **Aviation Insights**, a series of briefs centered around common questions about the aviation industry, to illustrate where the domestic air travel industry has been and where it is headed from an independent, objective perspective. In 2018, the Insights platform will be **a tool to answer new questions** that come up about the industry.



Analysis and Recommendations for FASTLANE to Inform Improvements

Eno's paper, **Life in the FASTLANE: Recommendations for Improving Federal Freight Grants**, provided concrete suggestions to target limited funds to freight projects that relieve bottlenecks and improve reliability for freight movements across the country. This work **primed a federal investigation calling for more transparency** in how funding gets awarded. Eno will continue to monitor its project selection process and the effectiveness of its results, under its new brand, INFRA.

Highlights from Eno Transportation Weekly (ETW)



Under Senior Fellow and Editor Jeff Davis, ETW continues to be **the leading voice for transportation insights both inside and outside the Beltway**. Within Washington, it is an indispensable source for government affairs professionals, Congressional staff, the U.S. Department of Transportation, and agencies across the Executive Branch. **In 2017, ETW published 501 articles and 18 opinion editorials** from experts across the country. Transportation leaders turn to ETW for in-depth analyses of federal legislation and comprehensive coverage of policy developments in DC and across the country.

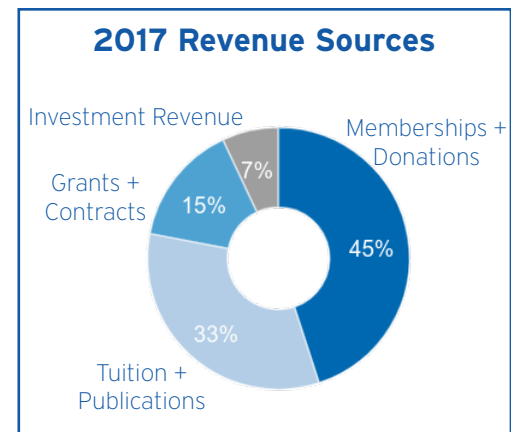
