SUBSTANTIVE PROVISIONS IN HOUSE BILL ONLY

- Secretary shall establish office of accident investigation, primarily to investigate aviation accidents (Sec. 3(f), House Bill)
- 3. Secretary to keep President advised of labor-management information and problems ("Horton amendment", Sec. 4(a), House Bill)
- 4. Secretary to give full consideration to need for operational continuity

of agencies transferred (Sec. 4(b), House Bill)

5. Statutory requirements re notice, hearing etc. apply to any Center for function transferred by Act (Sec. 4(c), House Bill)

6. Proviso to retain power of President to transfer the F.A.A. to Department of Defense during time of war (Sec. 6(c)(2), House Bill)
