Dear Chairman Sessions and Ranking Member Slaughter,

I write to inform you that I intend to urge Members to join me in opposing H.R. 5303, the "Water Resources Development Act of 2016", because the Republican Leadership overruled the bipartisan process of the Committee on Transportation and Infrastructure in developing this legislation, stripped a critical, bipartisan provision from the bill unanimously reported by the Committee, and presented a revised text to the Committee on Rules for consideration.

In addition, I write to request that the enclosed amendment be made in order. At the request of Republicans, the bill authorizes the U.S. Army Corps of Engineers to construct soccer fields, baseball fields, covered basketball courts, and a splash park as part of an \$810 million Texas project. Given that the Republican Leadership has broken our bipartisan agreement on this bill, I am able to openly oppose this waste of taxpayer dollars. My amendment prohibits using our limited Corps of Engineers budget to fund soccer fields, baseball fields, basketball courts, and splash parks as part of this project. In addition, the amendment requires the project be held to the same standard as other Corps of Engineers' projects and be economically justified.

Up until last week, H.R. 5303 was developed in the bipartisan tradition of the Committee on Transportation and Infrastructure with the Chairmen and Ranking Members of the Committee and the Subcommittee on Water Resources and Environment working in concert to produce a bill that could be supported by all Members. Unfortunately, the Rules Committee Print does not reflect the compromise that passed out of Committee. Without our consultation or agreement, the Republican Leadership overruled the bipartisan process of our Committee, and stripped Section 108 from the Committee-reported bill. The stripped provision would have unlocked the Harbor Maintenance

Trust Fund to ensure that revenues collected from shippers are used to maintain U.S. coastal and Great Lakes harbors – and not diverted to cover other debts of the U.S. Treasury. Over the past decade, less than <u>60 percent</u> of revenues collected in the Trust Fund have been used to maintain our Nation's harbors. Without this provision, the balance in the Trust Fund will double in the next decade to <u>\$20 billion</u> and continue to grow year after year, despite the tremendous needs of our Nation's ports and harbors.

I am incredibly disappointed that the Republican Leadership has sabotaged a good, bipartisan bill that would have maintained and strengthened our ports, harbors and waterways, and our Nation's economic competitiveness.

In addition, I am extremely concerned that despite Speaker Ryan's comments that the House should be using H.R. 5303 as a vehicle to address the ongoing tragedy facing the citizens of Flint, Michigan, the Republican Leadership has opposed every effort to include any assistance in this bill to help the city of Flint protect its citizens and children from ongoing health risks.

It is for these reasons that I plan to oppose H.R. 5303 when it is considered by the House.
