The STRR and DRIVE Acts vs the CBO Baseline - But Which One?

All of the Highway Trust Fund cash flow and year-end balance projections issued by the Congressional Budget Office have their spending calculated based on the "obligation baseline" - the annual obligation limitations on contract authority, which get annual inflation increases in the baseline, plus a flat \$739 million per year in contract authority exempt from obligation. But technically, under budget laws (and the House's CUTGO rule), the HTF contract authority baseline is flat-lined forever at the total provided in the last authorized year. As the tables below show, the gross spending in the House STRR Act strictly adheres to the inflation-adjusted obligation baseline, but in order to meet the other baseline test (and avoid running afoul of the House CUTGO rule), the House bill also rescinds \$6 billion in highway contract authority effective July 1, 2018 to keep the bill under the flat-lined baseline for the first three years as well. Corrected on 10/21 to fix transposition of a "6" and an "8" in Senate FY 2018 transit numbers.
